WHEREAS, the Annual Budget for Burlington Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 8, 2022; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$3,083,919.00 which includes an amount to be raised by taxation of \$2,443,000.00 and Total Appropriations of \$3,083,919.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 8, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 12, 2023.

Total budgeted appropriations will increase \$155,820. This increase is primarily in cost of operations and maintenance, \$119,769 and debt service, \$115,477. These increases are offset by a decrease in capital appropriations of \$110,000.

1. Election costs increase of \$2,500 or 100% due to increased cost of mail-in ballot printing services.
2. Office Supplies/Postage increase of \$1,000 or 14.3% due to inflationary cost increase of general office supplies and postage.
3. Fuel increase of \$5,000 or 20% due to increase in per gallon fuel prices.
4. Appropriations Offset With Revenue increased due to the anticipated hiring of a full time secretary in the Fire Prevention Division.
5. Total Principal Payments on Debt Service of 25.9% and Total Interest Payments on Debt Service of 40.1% due to the addition of a Capital Lease for the purchase of a new Ladder Truck. The new Ladder Truck replaces an existing 24 year old Ladder Truck.
6. ARP-FFG Expenses, \$33,000 or 100%. The District applied for and was awarded an ARP-FFG in the amount of \$33,000.
7. NJ Arm decrease of \$8,971 or 36.6% to more accurately reflect anticipated earnings on invested cash balances.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The amount to be raised by taxation will increase \$177,000 in 2023. Unrestricted fund balance of \$300,000 will be utilized in 2023 as compared to \$367,000 in 2022. Burlington Township Fire District No. 1 is in compliance with the property tax levy cap. The utilization of unrestricted fund balance will have no impact on the 2024 budget.
