WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 12, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

Total budgeted appropriations will increase \$676,092. The increase is primarily in total capital appropriations which are increasing \$547,000. The amount to be raised by taxation will increase \$145,000.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

- 1.) Fund balance utilized will increase \$642,000 or 158.5%. Restricted fund balance of \$697,000 will be utilized in 2025, none was utilized in 2024. These funds will be utilized toward the acquisition of a new ladder truck. Unrestricted fund balance of \$350,000 will be utilized in 2025 as compared to \$405,000 in 2024.
- 2.) Operating grant revenue and ARP-FFG expenses will decrease \$75,000 in 2025 or 100%.
- 3.) Total administration will increase \$191,174 or 57.3%. This increase relates to a new position of Battalion Chief.
- 4.) Interest payment on debt will decrease \$13,607 or 18.1%. This is offset by an increase in principal of \$14,907.
- 5.) Uniform Fire Safety Act annual registration fees will increase \$23,000 or 14.4%. This increase is to more accurately reflect anticipated fees.
- 6.) Fire prevention programs will decrease \$38,376 or 28.7% due to a reduction in the cost of operating the Bureau.
- 7.) Maintenance and repairs will increase \$37,500 or 27.3% due to the cost increases on both parts and labor. Equipment will be another year older and require more maintenance.
- 8.) Medical services will increase \$6,500 or 35.1%. The District requires annual physicals for career and volunteer firefighters and the cost has increased for these physicals. The 2024 line item was exceeded by \$2,500.
- 9.) SOP Review will increase \$16,000 or 100%. They have not been reviewed nor updated in over ten (10) years and now that the District has career staff specific SOP's need to be added.
- 10.) Strategic Plan will increase \$24,000 or 100%. With the completion of the master plan, the new strategic plan needs to implement the recommendations in the short term.

Restricted fund balance of \$697,000 will be utilized in 2025, none was utilized in 2024. Burlington Township Fire District No. 1 is in compliance with the property tax levy cap. The utilization of unrestricted fund balance will have no impact on the 2026 budget.
